

End user license agreement (EULA)

Please read this EULA carefully, as it sets out the basis upon which we license the Software for use.

This Limited Use License Agreement (“License”) sets forth the Terms and Conditions for use of the GridEye People Tracking and Counting Software (“Software”) provided by PANASONIC CORPORATION, acting through its Device Solutions Business Division of Automotive & Industrial Systems Company, 1006 Kadoma, Kadoma City, 571-8506, Japan, a Japanese corporation (“AIS”) to the customer (“you” or “Licensee”). The license includes any software updates and supplements that AIS may provide you after the date you obtain the Software.

By clicking "Accept" when you first start the Software, you agree to be bound by the provisions of this EULA. If you do not agree to be bound by the provisions of this EULA, you must click "Decline" during the installation process and promptly uninstall the Software.

By agreeing to be bound by this EULA, you further agree that you and any person you authorize to use the Software will comply with the provision of this EULA.

Generally

AIS owns the copyright of the Software.

License

Subject to the terms and conditions of this License AIS hereby grants you a non-transferable, non-exclusive and royalty-free right to install, use and reproduce the Software solely in conjunction with the GridEye Evaluation Kit for incorporation in and subsequent distribution of Licensee’s product. You acknowledge that you are receiving only a LIMITED LICENSE TO USE the Software and that you shall obtain no title, ownership nor any other rights in or to the Software nor in or to the algorithms, concepts, designs and ideas represented by or incorporated in the Software. This is a license agreement and not an agreement for sale.

Restrictions

Except to the rights granted under the provision “License” of this Agreement you may not (a) use, copy and/or transfer the Software to any third party apart from the GridEye Evaluation Kit, (b) sell, resell, rent, lease, loan the Software, (c) modify the Software or (d) attempt to reverse engineer, decompile or disassemble any portion of the Software.

Source Code

Nothing in this EULA shall give to the User or any other person any right to access or use the Source Code or constitute any license of the Source Code.
